A RESOLUTION REQUESTING GOVERNOR EPIMACO VELASCO AND THE SANGGUNIANG PANLALAWIGAN OF CAVITE FOR FINANCIAL ASSISTANCE FOR THE CONCRETING OF A 500-METER ROAD CONNECTING THE SILANG PUBLIC MARKET TO THE AGUINALDO HIGHWAY BY-PASS.

WHEREAS, the newly-opened 500-meter road linking the Silang Public Market with the Aguinaldo Highway bypass is a dirt road and is most often not passable because of the deep mud;

WHEREAS, the subject road if made into an all-weather road, will render it passable at all times and will greatly improve the flow of vehicular traffic and consequently enhance commercial activities in the area particularly during market days;

WHEREAS, the optimal use of the subject road will benefit tremendously the users of the Silang Public Market especially the hundreds of farmers-producers in the area;

WHEREAS, the municipality of Silang is not in a position to finance the concreting of said road on account of its present financial predicament;

RESOLVED, AS IT IS HEREBY RESOLVED on motion of Hon. Jose Patawe, seconded by Hon. Santos, that a request for financial assistance for the concreting of said road be made from Governor Epimaco Velasco and the Sangguniang Panlalawigan of Cavite.




